

EXHIBITOR AGREEMENT

GBAHB BUILDER APPRECIATION NIGHT

March 23rd, 2010
PELHAM CIVIC COMPLEX

This agreement is made this ___ day of _____, 20____, between the Greater Birmingham Association of Home Builders (GBAHB) and _____ herein after referred to as the "Exhibitor." The Exhibitor agrees to pay for the use of _____ exhibit space(s) for the sum of \$_____ subject to the following conditions:

- 1. ELIGIBLE EXHIBITORS:** Any member firm in good standing with GBAHB is eligible to purchase exhibit space at the member rate. Any non-member of the Association that is approved by the Associates Council is eligible to purchase exhibit space at the non-member rate(**10w x 10d**). This space is subject to availability and no one firm will be given preference to space without having first submitted payment in full along with this agreement to the Association office. However, the Association has the right to refuse any space to any Exhibitor whose exhibit is deemed inappropriate.
- 2. LIMITATION: NO FOOD OR DRINK TO BE DISTRIBUTED FROM BOOTHS AT ANYTIME.** No construction, nailing, taping or building of exhibits shall occur on the exhibit floors, walls or physical building of the facility. Displays must be contained within the booth space. All exhibits must be vacated in a timely manner as directed by the Pelham Civic Center staff.
- 3. SALES:** No "physical" selling of goods or wares will be allowed. Violation of this clause will be subject to eviction.
- 4. LIABILITY:** The Exhibitor agrees to hold harmless and to make no claim against GBAHB for loss, theft, damage or destruction of foods or personal injury during set-up, break-down or while the show is in progress.
- 5. PAYMENT:** The cost of exhibit space for GBAHB **members** is **\$500.00** for **Premium** (see **NOTE on page 2**) booths and **\$400.00** for all other booths. The cost of exhibit space for **non-members** is **\$625.00** for **Premium** booths and **\$500.00** for all other booths. Payment should be made to **GBAHB**. **Payment in full only will reserve a booth.** Booth reservation includes **two complimentary admission tickets per booth;** all additional admissions will be **\$30.00** each.
- 6. DEADLINE:** March 9, 2010 (Booths are sold on first come first served basis).

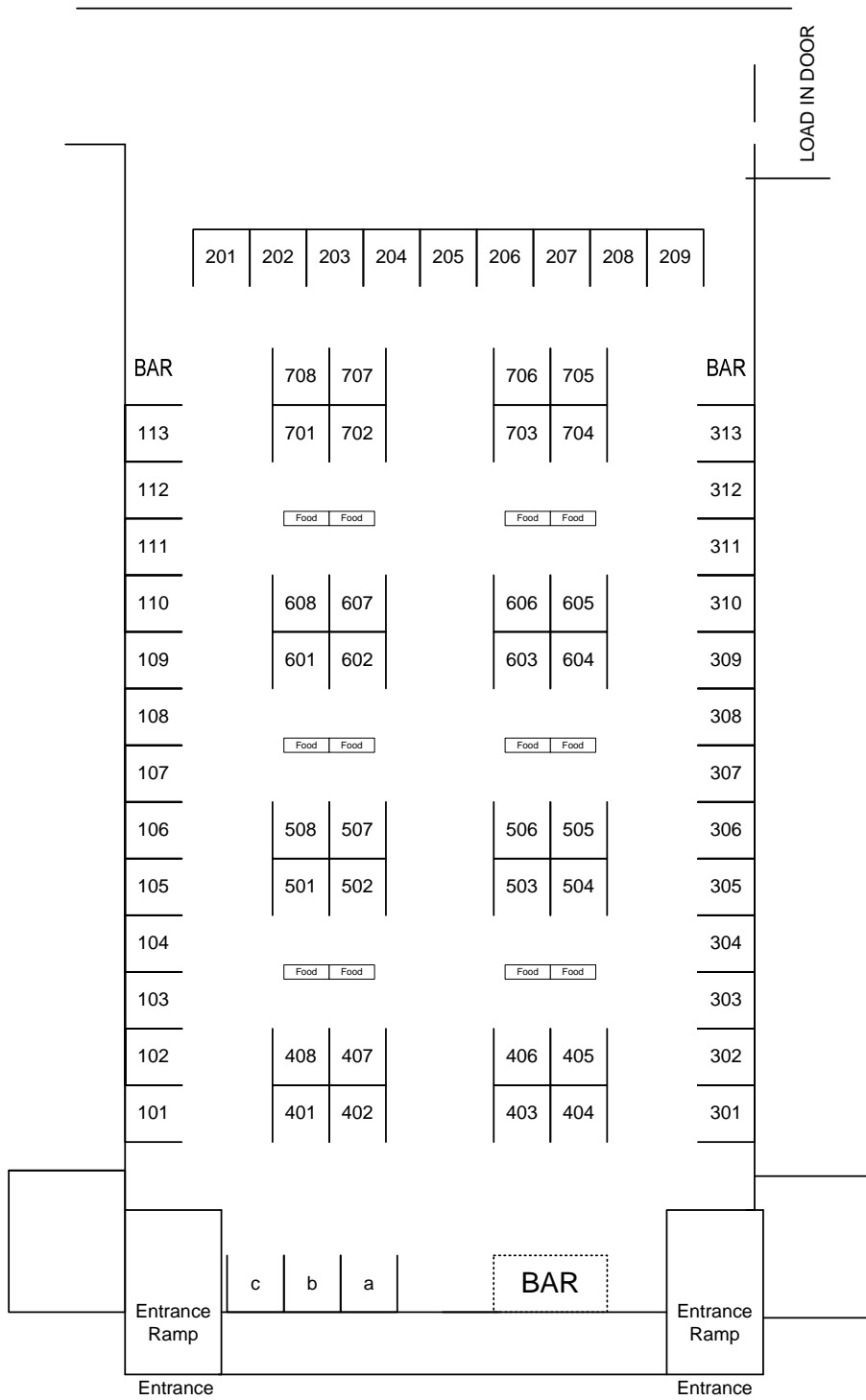
