

# EXHIBITOR AGREEMENT

## Green Home Expo

April 17-18 & 24-25, 2009  
Viridian Development, Vestavia Hills, AL

This agreement is made on the date of \_\_\_\_\_, between the Greater Birmingham Association of Home Builders (GBAHB) and \_\_\_\_\_ herein after referred to as the "Exhibitor." The Exhibitor agrees to pay for the use of \_\_\_\_ exhibit space(s) for the sum of \$\_\_\_\_\_ subject to the following conditions:

1. **ELIGIBLE EXHIBITORS:** Any member firm in good standing with GBAHB is eligible to purchase exhibit space at the member rate. Any non-member of the Association that is approved by the Associates Council is eligible to purchase exhibit space at the non-member rate. This space is subject to availability and no one firm will be given preference to space without having first submitted payment in full along with this agreement to the Association office. However, the Association has the right to refuse any space to any Exhibitor whose exhibit is deemed inappropriate. The final decision rests with the Associates Council.
2. **LIMITATION:** Displays must be contained within the booth space. All exhibits must be vacated in a timely manner as directed by the GBAHB staff.
3. **SALES:** No "physical" selling of goods or wares will be allowed. Violation of this clause will be subject to eviction.
4. **LIABILITY:** The Exhibitor agrees to hold harmless and to make no claim against GBAHB for loss, theft, damage or destruction of goods or personal injury during set-up, break-down or while the show is in progress. Green Home Expo will not be open during the week. However, the tent will remain erected. Exhibitors are highly encouraged to tear-down exhibits on Sunday, April 18<sup>th</sup> and set up again on Sunday, April 24<sup>th</sup>. The GBAHB will not be responsible for the loss or theft of any goods.
5. **PAYMENT:** The cost of exhibit space for GBAHB members is \$450. The cost of exhibit space for non-members is \$570.

**Green Home Expo and Builder Appreciation Night Bundle Package** – Exhibitors who purchase a **Builder Appreciation Night** tradeshow booth will receive a 20% discount on the Green Home Expo booth.

Payment should be made to GBAHB. **Only payment in full will reserve a booth.**

6. **DEADLINE:** Exhibitor Agreement Deadline is March 12th.
